

CUSTOMERS MAY EXPERIENCE A BOUNCY RIDE, NOISE, OR LEAKING FLUID NEAR THE REAR WHEELS PRIOR TO THE DETACHMENT OF AN EXTERNAL RESERVOIR.

Glossary
