Description: Due to moisture accumulation over time, both reverse lamps on the subject vehicles can stop working. If this occurs, the driver?s view to the rear can be limited when

At this time, Toyota estimates the remedy will begin to be available in the 4th quarter of 2025, and we anticipate rolling out this remedy in phases. This remedy will also address other conditions resulting from the moisture intrusion (see FAQ for additional details).


