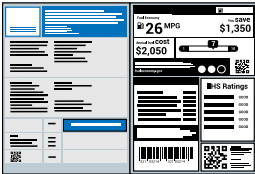

Description: IN SOME OF THE AFFECTED VEHICLES, WATER CAN INGRESS AT THE INTERFACE BETWEEN THE CAMERA AT THE TOP OF THE TAILGATE AND THE TAILGATE PARK ASSIST SENSOR INTERFACE MODULE TPASIM, WHICH MAY LEAD TO A MALFUNCTION IN THE REAR-VIEW CAMERA SYSTEM.

IF THE REAR-VIEW CAMERA SYSTEM MALFUNCTIONS, YOU COULD EXPERIENCE A BLUE OR BLACK SCREEN OR AN INTERMITTENT LOSS OF THE REAR CAMERA DISPLAY WHILE THE VEHICLE IS IN REVERSE. A LOSS OF THE REAR CAMERA IMAGE WHILE IN REVERSE INCREASES THE RISK OF A CRASH.

Commercial

Vehicle was registered for business purposes.

First Owner

When the first owner(s) obtains a title from a Department of Motor Vehicles as proof of ownership.

Ford or Lincoln Mercury Recall

Manufacturer Recall

Ownership History
