**Description:** The rear brake hoses in the subject vehicles can be damaged over time if there is enough build-up of mud/dirt inside the rear wheels from operating under certain off-road conditions.

This can result in a brake fluid leak, increasing the risk of crash.

**Remedy:** The remedy, when available, will involve replacement of both rear brake hoses with improved ones FREE OF CHARGE. Toyota is conducting a phased implementation of the remedy based on the owner's vehicle model. Refer to the tables below to determine the remedy status for the vehicles involved in this Safety Recall.

## Glossary

### Commercial

Vehicle was registered for business purposes.

### First Owner

When the first owner(s) obtains a title from a Department of Motor Vehicles as proof of ownership.

### Manufacturer Recall

Automobile manufacturers issue recall notices to inform vehicle owners of a safety defect or failure to meet minimum federal safety or emissions standards. Manufacturer recalls are repaired at no cost to the customer.

### Ownership History

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership. To provide estimated number of owners, CARFAX proprietary technology analyzes all the events in a vehicle history. Estimated ownership is available for vehicles manufactured after 1991 and titled solely in the US including Puerto Rico. Dealers sometimes opt to take ownership of a vehicle and are required to in the following states: Maine, Massachusetts, New Jersey, Ohio, Oklahoma, Pennsylvania and South Dakota. Please consider this as you review a vehicle's estimated ownership history.

### Service Campaign

Automobile manufacturers issue a service campaign to address product technical issues that may not be related to safety or emissions standards. These issues are typically customer satisfaction initiatives.

### Title Issued

A state issues a title to provide a vehicle owner with proof of ownership. Each title has a unique number. Each title or registration record on a CARFAX report does not necessarily indicate a change in ownership. In Canada, a registration and bill of sale are used as proof of ownership.
