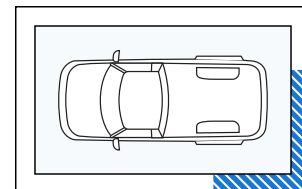

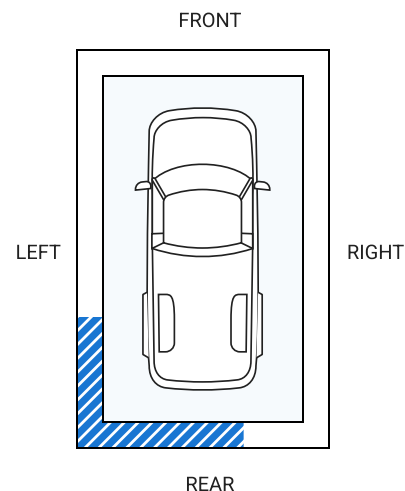

**Description:** Toyota is conducting a safety recall involving certain MY 2025 Tacoma 4-wheel drive vehicles. A part used in the front drive shaft joint in the subject vehicles may not have been manufactured with the correct material and can deform or break while driving. If it deforms or breaks, the driver may not be able to complete a turn as intended. If the part breaks, and the vehicle is a full-time 4WD model, the vehicle may move while the transmission is in Park without the Electronic Parking Brake applied.

This may increase the risk of a crash.

**Remedy:** Toyota is currently preparing the remedy. When remedy becomes available, dealers will inspect the front drive shaft assembly serial numbers and replace one or both front drive shaft assemblies for all involved vehicles if found to be from the affected production period FREE OF CHARGE.

## Glossary

### Accident Indicator

CARFAX receives information about accidents in all 50 states, the District of Columbia and Canada.

- According to the National Safety Council, Injury Facts, 2021 edition, 5% of the 276 million registered vehicles in the U.S. were involved in an accident in 2019. Over 77% of these were considered minor or moderate.
- This CARFAX Vehicle History Report is based only on information supplied to CARFAX and available as of 12/30/25 at 1:44:35 PM (CST). Other information about this vehicle, including problems, may not have been reported to CARFAX. Use this report as one important tool, along with a vehicle inspection and test drive, to make a better decision about your next used car.

### Damage Severity

Damage events result in one of the following severity levels:

- Minor: Generally, minor damage is cosmetic (including dents or scratches), may only require reconditioning, and typically does not compromise a vehicle's operation and/or safety.
- Moderate: Moderate damage may affect multiple components of the vehicle and may impair the vehicle's operation and/or safety.
- Severe: Severe damage usually affects multiple components of the vehicle and is likely to compromise the vehicle's operation and/or safety.

### First Owner

### Manufacturer Recall

Automobile manufacturers issue recall notices to inform vehicle owners of a safety defect or failure to meet minimum federal safety or emissions standards. Manufacturer recalls are repaired at no cost to the customer.

### Ownership History

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership. To provide estimated number of owners, CARFAX proprietary technology analyzes all the events in a vehicle history. Estimated ownership is available for vehicles manufactured after 1991 and titled solely in the US including Puerto Rico.
