Description: THE TRANSMISSION OIL COOLER TUBE MAY COME IN CONTACT WITH THE POWER STEERING FLUID RETURN TUBE. PROLONGED CONTACT OF THE TUBES COULD CAUSE A LEAK IN THE TRANSMISSION OIL COOLER TUBE.

OPERATING THE VEHICLE WITH INSUFFICIENT TRANSMISSION FLUID MAY CAUSE DAMAGE TO THE TRANSMISSION AND A LOSS OF TRANSMISSION FUNCTION WHICH MAY INCREASE THE RISK OF A CRASH.

Remedy: THE POWER STEERING FLUID RETURN TUBE MUST BE REPLACED ON ALL INVOLVED VEHICLES AND THE TRANSMISSION OIL COOLER TUBE MUST BE INSPECTED FOR DAMAGE. TRANSMISSION OIL COOLER TUBES THAT ARE FOUND TO BE DAMAGED MUST BE REPLACED. TRANSMISSION OIL COOLER TUBES THAT ARE NOT DAMAGED MUST HAVE A PROTECTIVE SLEEVE INSTALLED.

Glossary

First Owner

When the first owner(s) obtains a title from a Department of Motor Vehicles as proof of ownership.

Manufacturer Recall

Automobile manufacturers issue recall notices to inform vehicle owners of a safety defect or failure to meet minimum federal safety or emissions standards. Manufacturer recalls are repaired at no cost to the customer.

New Owner Reported

When a vehicle is sold to a new owner, the Title must be transferred to the new owner(s) at a Department of Motor Vehicles.

Ownership History

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership. To provide estimated number of owners, CARFAX proprietary technology analyzes all the events in a vehicle history. Estimated ownership is available for vehicles manufactured after 1991 and titled solely in the US including Puerto Rico. Dealers sometimes opt to take ownership of a vehicle and are required to in the following states: Maine, Massachusetts, New Jersey, Ohio, Oklahoma, Pennsylvania and South Dakota. Please consider this as you review a vehicle's estimated ownership history.

Title Issued

A state issues a title to provide a vehicle owner with proof of ownership. Each title has a unique number. Each title or registration record on a CARFAX report does not necessarily indicate a change in ownership. In Canada, a registration and bill of sale are used as proof of ownership.
