Description: General Motors has decided to conduct a voluntary emissions recall involving certain 2016-2019 model year diesel engine vehicles. The engine control module (ECM) in these vehicles may not adequately diagnose or illuminate the malfunction indicator lamp (Check Engine Light) when frequent regeneration of the diesel particulate filter (DPF) occurs.

Description: General Motors has decided that a defect which relates to motor vehicle safety exists in certain 2017-2019 model year Chevrolet Silverado 2500/3500 and GMC Sierra 2500/3500 vehicles. In vehicles equipped with the Duramax diesel 6.6 liter engine and the

optional engine-block heater cord, a short-circuit condition may develop in the engine-block heater cable or in the terminals that connect the heater cable to the block heater.

A short-circuit condition can cause damage to engine components and, in rare cases, start a fire in the engine compartment.

Remedy: Dealers will replace engine block heaters and heater cords in cold weather areas using pre-shipped parts. Dealers are to continue to perform the engine block disable procedure on inventory only vehicles and for customers that request disabling because replacement parts are not yet available. Customers may decline disabling but should be advised to NOT use the block heater system until the system is replaced. Vehicles that have this feature disabled as a remedy to the safety condition will be contacted and offered replacement block heaters and heater cords under a separate customer satisfaction program. Chevrolet Silverado and GMC Sierra 2500/3500 vehicles included in recall 19V328 will be closed under that recall number and addressed under this recall campaign. For this population of vehicles, the heater cord will also be replaced and rerouted by the dealer to address chafing or damage due to improper routing, use, or storage of the existing heating cord.

Glossary

First Owner

When the first owner(s) obtains a title from a Department of Motor Vehicles as proof of ownership.

Manufacturer Recall

Automobile manufacturers issue recall notices to inform vehicle owners of a safety defect or failure to meet minimum federal safety or emissions standards. Manufacturer recalls are repaired at no cost to the customer.

Ownership History

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership. To provide estimated number of owners, CARFAX proprietary technology analyzes all the events in a vehicle history. Estimated ownership is available for vehicles manufactured after 1991 and titled solely in the US including Puerto Rico. Dealers sometimes opt to take ownership of a vehicle and are required to in the following states: Maine, Massachusetts, New Jersey, Ohio, Oklahoma, Pennsylvania and South Dakota. Please consider this as you review a vehicle's estimated ownership history.
